## Two Horse Owners Workshops scheduled at TAMU –February 2010

#### Mare/Foal Management Workshop

Mare owners seeking information on broodmare management and raising foals will have an opportunity to attend a one-day program focusing on just that at the 12<sup>th</sup> Annual Mare/Foal Workshop on Wednesday, February 24<sup>th</sup>, 2010 at Texas A&M University.

The workshop will be held at the Louis Pearce Pavilion. This workshop will present information regarding Herd Health and Immunizations, Foal Health, Feeding Broodmares and Foals, The Estrous Cycle, Parturition and Sign of Foaling and Genetic Related Disorders.

This one-day workshop is designed for mare owners. It is not intended to be a breeders school and will focus much more on mare management than on breeding procedures. The information should be useful for the mare owner, regardless of the number of mares they own or manage.

#### Horse Management 101 Workshop

Horse owners seeking information on basic horse management will have an opportunity to attend a day-long program focusing on just that at the  $7^{th}$  Horse Management 101 Workshop on February  $25^{th}$ , 2010 at Texas A&M University.

This workshop will be held at the Louis Pearce Pavilion on the campus of Texas A&M University. This workshop will present information regarding General Health Care and Immunizations, First Aid, General Nutrition, Hay and Feed Storage, Concerns for Small Acreage Owners, Equine Genetics and Managing the Geriatric Horse.

This one-day workshop is designed for individuals that are seeking more information to better care for their horses. Additionally, this workshop is a tremendous opportunity for individuals to attend and obtain more information prior to getting a horse.

Instruction for both programs will be provided by equine faculty from both the Equine Science Section of the Animal Science Department and the College of Veterinary Medicine and Biomedical Sciences.

You must pre-register to attend the workshops. Registration includes printed materials, light breakfast and noon meal. Programs begins at 8:00 a.m. with registration. The cost for each Equine Owner Education Workshop is \$50.00/workshop and online registration will be accepted through February 15, 2010. Late online registration is \$60.00/workshop and will be accepted from February 16 through February 19, 2010. Registration at the door is \$70.00/workshop. ### **Prowl H2O Supplemental Label Information**

If you are having problems with field sandbur (grassbur) in your pastures or hay meadows –this information will be of interest to you. BASF has received a supplemental label allowing application to **dormant** bermudagrass pasture and hay meadows for control of grassbur and other weed species (numerous annual grasses and small seeded broadleaf weeds) listed on the full label.

This label expires on December 31, 2010

Label details to note:

- Rate: 1.1 4.2 qts/ac; maximum of 4.2 qts per year
- Timing: Anytime during winter dormancy and prior to weed germination
- Methods: Ground, chemigation, and air
- PHI: 60 days prior to harvest for hay; 45 days prior to grazing/harvest for forage
- Pastures and hay meadows (no rangeland)
- Bermudagrass varieties: All, but must be an established stand (have gone through at least one cutting)
- Target: field sandbur; annual grass and broadleaf weeds
- Activation: 1" of precipitation ideal prior to weed germination

### **Beef Cattle Browsing**

#### WHERE DID EUROPEAN CATTLE COME FROM?

Scientists at 15 research entities from around the world collaborated on a study of 48 breeds of cattle using genomic techniques. It was concluded that European cattle arose in the Fertile Crescent, sometimes called the Cradle of Civilization, in parts of what is now Israel, Iraq, Iran, Jordan, Lebanon, and Syria. From there movement was through Turkey, the Balkans, and Italy, dispersing through Central Europe and France and then to the British Isles. A second route appeared to be from Africa or the Fertile Crescent across the sea to the Iberian Peninsula. The authors speculated that knowledge of the evolution of breeds could lead to a better understanding of their genetic relationships. For instance, it would be helpful to know if breeds that excel in marbling are closely related or not. If not, different approaches could be needed in using genomic methods to improve marbling in all cattle. (Proc. of Nat. Acad. of Sciences 106:44 and Univ. of Missouri press release)

#### EFFECT OF DISEASE ON CARCASS TRAITS

The effects of bovine respiratory disease (BRD) and overall incidence of pathogenic diseases (IPD) on carcass traits were investigated. Two groups were studied. The first (GP1) included 642 crossbred steers involving seven British and Continental breeds. The second (GP2) included 621 crossbred steers involving tropically-adapted Bos taurus and Bos indicus-

influenced breeds as well as British breeds. Treatment incidence for BRD was 20% in GP1 and 24% in GP2. In both groups, cattle treated for BRD or IPD had significantly lower fat cover and numerical Yield Grade. There was a tendency for treatment in GP1 to lower percent Choice. Mechanical estimate of tenderness was significantly lower in GP2 treated for BRD, but not in GP1. These results agree with most previous research that respiratory and other sickness results in adverse effects on carcass merit. (U. S. Meat Animal Research Center; J. Animal Sci. 88:491)



## Pesticide Licensing Class & Testing -February 24th, 2010

Agricultural producers who need to obtain a Texas Department of Agriculture –Private Pesticide Applicator License will want to sign up for our next Pesticide Licensing Class. This class is scheduled for Wednesday, February 24, 2010. We will begin at 8:30 AM with the class session which will run until about Noon. Following a brief lunch break, we will reconvene at approximately 1:00 PM for the TDA testing session.

If you would like to sign up for this class, please contact the Texas AgriLife Extension Service, Walker County at (936) 435-2426. **Enrollment in the class is required.** The class fee, including the required study guide and worksheets is \$30.00 per person. Participants meeting successful testing requirements will be required to submit \$60.00 to the Texas Department of Agriculture for their Private Applicator licensing fee. This license will be valid for 5 years to the date of issuance. At the end of 5 years, each license holder will be required to have participated in 15 hours of CEU course work with 2 hours of Laws & Regs and 2 hours of Integrated Pest Management credit.

Provisions from the American Disability Act will be considered when planning educational programs and activities. Please notify the Walker County Extension Office if you plan on attending an Extension Educational program and need specialized services. Notification of at least two weeks in advance is needed, so that we may have ample time to acquire resources needed to meet your needs.
