FYI: The Next Brand Registration will be August 30, 2011 thru February 28, 2012


All Livestock Brands Expire

2010. F.E. Hill Company is a multifaceted agricultural enterprise that has been known in Freestone County for extremely high quality hay production, and intensive beef herd management characterized by progressive reproductive practices. The ranch also uses an intense land management program that allows them to decrease production cost. Waterfowl and Whitetail Deer are managed for and are abundant on their property. Topics discussed at this Cow Country Congress will include new methods in feral hog control, wildlife diversification on the ranch, fly control in the cow herd, and genetics and their role at Hill Cattle Company. A live cattle handling demonstration will also be provided along with a discussion by the Luminant Power Big Brown Complex Reclaim Team. The site where the event will be hosted is a reclaim site resulting from coal mining operations in the area. The team will discuss the reclaim process and share some recommendations on land management. This event will also showcase truly outstanding facilities for working cattle.

Program registration will begin at 8:15 AM. The program will begin with introductions at 8:45 AM. Individuals from Walker County interested in attending the 2010 Cow Country Congress should R.S.V.P. prior to September 21st to the Walker County Extension Office (936) 435-2426. A registration fee of \$10.00 per person will provide each participant a Barbeque Lunch with all the trimmings! In addition to the benefits of a catered lunch, on-site commercial vendors, and touring the ranch operation, each participant with a Texas Department of Agriculture-Pesticide Applicators License will be eligible for 2 IPM hours of Continuing Education Credits for renewal of their license. Additional participant credit of 1.5 hours will be given for Beef Quality Assurance

(BQA) recertification.

Private Applicator Licensing Class & Testing Session at the Walker Co Extension Office

Agricultural producers needing a Private Applicator License to purchase and apply restricted use or state-limited use pesticides (herbicides, insecticides, etc.) can attend our next class on **Friday, September 10th, 2010**. The class will begin with registration at 8:00 AM and will run until 12:00 PM. At 1:00 PM the Texas Department of Agriculture representative will be on hand to administer the test. RSVP is required and you must purchase and pick up your study material prior to the class. The class fee, including all study material is \$35.00 per person. Following completion of the class and successful testing, the fee for a Private Applicator License is \$60.00 for 5 years. Private Applicators are required to receive 15 hours of continuing education credits during the 5 year period to renew their license.

demonstration on attracting butterflies to your garden. In addition, there will be other exciting horticulture presentations & projects!



MAINTENANCE OF AEROBIC TREATMENT UNITS October 22, 2010 (9:00 AM - 4:30 PM)

Walker County, Texas AgriLife Extension Office

Course Fee: \$50.00 per person

Interested in learning about homeowner maintenance of Aerobic Treatment Units? This course will cover the components of an aerobic treatment unit and spray field onsite wastewater treatment systems. The course presentations discuss the importance of maintaining the treatment system, health and safety considerations, basic concepts about the aerobic treatment processes, testing and reporting on the status of the treatment system, care and feeding of the aerobic treatment unit, maintaining the aerobic treatment system and tools and supplies for evaluating the system. These presentations provide a basic understanding of the operational and maintenance activities for an aerobic treatment unit. The course explains ho activities within the home can impact the operation of an aerobic treatment unit. The participants will leave this class with a better understanding of the practices required to keep their system working and limit interferences with the enjoyment of their property.

October 12-15, 2010 in College Station, TX. Are you a new rural landowner? Do you have limited experience in forage establishment, pasture management, and utilization? Are you interested in raising livestock? Are you interested in managing the wildlife on your property? Or, are you simply interested in becoming the best steward of your natural resources that you can be? If you answered yes to any of these questions, then you are a great candidate for the Texas AgriLife Extension Service Ranch Management University. Go to http://agrilifevents.tamu.edu and type in the key words "ranch management" for registration information.

Topics will include soils & soil fertility, forage species selection, hay production, weed & brush management, beef cattle breed selection, nutrient requirements and feeding strategies for livestock, grazing management and the popular chute-side live animal handling demonstrations of vaccinations, dehorning, and castration. Additional topics include: white-tailed deer management, dove, turkey, quail, pond management and what to do with feral hogs.
