On Monday April 16, 2018 there will be an East Texas Pecan Conference and Field Day with registration starting at 7:45 a.m., program will begin at 8:30 a.m. Location is 2019 W. Oak Street at Ben E Keith in their meeting room. We ask that you RSVP by April 13, 2018 by contacting the Anderson County Extension Office at 903-723-3735. Cost for this program is \$20.00, includes lunch and 2 CEU's; 1 hr IPM and 1 hr General. The afternoon part of this program we will travel to Texas Pecan Lakes Ranch, Palestine, Tx, located at 3131 Anderson County Road 2101.

This conference and field trip is designed to assist Homeowner Pecan Producers as well as Commercial Pecan Producers. If you have questions about insects, disease, fertilizing, zinc or watering existing trees then you don't want to miss this event. Perhaps you are interested in starting a Pecan Orchard you will want to attend this program. Topics for this program will be, Early Season Pecan Disease Management, Fertility Management of Pecans, Orchard Rehabilitation and Grafting, Weevils and Orchard Management Discussion.

Speakers include Monte Nesbitt Extension Program Specialist with Texas A&M AgriLife Extension. He works throughout the State of Texas on Pecans, Temperate Fruits and Citrus. He also conducts research on Fruits and Nuts in the areas of Propagation, Freeze Protection, Water Management and Variety Performance. Bill Ree, Extension Program Specialist, Bill directs the statewide Pecan IPM Program focusing on Pecan IPM information to assist pecan growers on how to manage pest in an economically effective and environmentally friendly. His work includes all important Insect Pest of Pecans in the Southwest, Insects and Disease Complexes. Truman Lamb, Anderson County Extension Agent Ag/NR. Lamb has worked pecans since 1984 including Variety Trials, Fertility Studies, Insect and Disease, Result Demonstrations and Research, Lamb also conducts several Pecan Grafting Clinics each year throughout East Texas.

Grassbur (Field sandbur)

With sandy, acidic, low nitrogen type soils you can expect to encounter this plant sooner or later... Here is a good, quick read on identification of Field sandbur: https://foragefax.tamu.edu/2018/04/04/weed-of-the-week-grassbur-field-sandbur-etc/

Keep in mind that chemical control options for pasture and turfgrass will <u>not</u> be the same products. If you noted my description of the environment where this plant is commonly found, you know what needs to change to ultimately solve the situation. Soil pH and nitrogen fertilizer will help greatly by encouraging the growth or establishment of desirable plants. The problem is that can become an expensive situation depending on where you are working to modify those environmental conditions.
